

THE COUNTY BOARD OF BIG STONE COUNTY, MINNESOTA, HEREBY ORDAINS:

1997 Legislative amendments to Minnesota Statutes 1996, sections 115.55, subdivisions 1, 2, 3, 5, 6, 7, and added subdivision 115.57, subdivision 7; more specifically:

AN ORDINANCE AMENDING SUBDIVISION 1: PARAGRAPH 1, SECTION 4.41 OF THE BIG STONE COUNTY SEWAGE TREATMENT ORDINANCE passed and approved by the Board of County Commissioners on September 16, 1997.

“SUBDIVISION 1: GENERAL PROVISIONS

The provisions of this Ordinance apply to ~~all areas outside the incorporated limits of any municipality~~ the entire county except the cities and towns that have adopted ordinances that comply with Chapter 7080 and are at least as strict as the applicable county ordinance, and including shoreland areas. To the extent that the provisions of the Shoreland Management Ordinance and the Big Stone County Land and Related Resources Ordinance are inconsistent with or less restrictive than the provisions of this Ordinance, the provisions of this Ordinance dealing with Individual Sewage Systems takes precedence.”

Section 4.41 of the Big Stone County Sewage Treatment Ordinance adopted by the Board of County Commissioners on September 16, 1997, is hereby amended to include an additional paragraph which reads as follows:

“Upon inspection, if an existing system is not found to be an imminent public health threat and provides at least two feet of soil separation, the system need not be upgraded, repaired, replaced or its use discontinued, except for the following circumstances:

- New ISTS construction and replacement;
- Systems in shoreland;
- Systems in wellhead protection areas; and
- Systems serving food/beverage/lodging facilities.

This ordinance shall become effective and be in force from and after its passage, approval, publication and recording in the office of the County Recorder.

All other terms and conditions of the said Big Stone County Sewage Treatment Ordinance shall remain in full force and effect.
